1 General

Suppliers providing goods under CIP, CPT or DAP terms to Switzerland please refer directly to section 7 and 8. Suppliers providing goods under freight paid by HUBER+SUHNER terms (FCA, EXW), please follow the "procedure" below.

Any shipping instructions given explicitly in the purchase order by HUBER+SUHNER, have priority over these general instructions, e.g. you might be advised to use "airfreight" or "express" in the purchase order.

Procedure:

- 1. Choose the regional instructions (2 CH, 3 PL, 4 TN, 5 DE) depending on the destination country.
- 2. Find service and provider according to the line defined by weight **and** volume of your shipment. If weight and volume point to different lines, the slower service is to be used. Mind the plan transit time given in **working days** to meet the requested delivery date.
- 3. Find forwarder contact information and account numbers to be used in section 6.

<u>Insurance</u>: Never request shipment specific insurance in any transport orders to carriers. HUBER+SUHNER transports are covered by a global insurance policy.

Transport advise: Please make sure the transport advise includes

Pick up address, contact name&phone, loading times, number/weight/dimension of packages, invoice, packlist

<u>Shippers regions</u>: EUROPE – AMERICAS (North + South) – ROW (Rest of world) If country specific instructions are given, they have priority over regions.

7 General brokerage Switzerland

In order to ensure the flow of information and to harmonize the process of customs clearance we nominated Rhenus Logistics as our general customs broker for shipments consigned to Switzerland. Shipments with delivery condition DDP and those made by courier or parcel service are excluded from this regulation.

When submitting the transport order to your nominated forwarder, would you please in addition instruct your forwarder to cede clearance to Rhenus Logistics and notify our customs broker as follows:

Required documents

- Commercial or Customs invoice
- EUR1 or Rex declaration
- Packing list
- Waybill

Please note that it will not be necessary for your nominated carrier to cross the border at Thayngen, they can use any border crossing of their choice and Rhenus will supply the entry documents to the respective local agent or office. The cession will not incur any costs to you or your nominated forwarder but will ensure clearance at agreed processes and cost for HUBER+SUHNER. At the same time we do not accept cession fees raised by your forwarder.

Documentation requirements European Union, Switzerland

As of 1st March 2023 new regulation for imports into Europe will have to be considered as ICS 2.0 will replace the former ICS 1.0. ICS being the short for Import Control System.

What is new?

- 1. EORI number of importer must be given in freight documents (airway bill, courier waybill, sea freight bill of lading), thus the forwarder will ask for the number.
- 2. Item descriptions must be more clear
- 3. Commodity codes for items must be given (at least 6 digits of the HS code)

8.1 Which EORI number to use for which H+S entity

EORI numbers identify the importer in the EU unambiguously, each importer has to apply for an EORI with their customs authority.

The following are to be used when shipping to H+S plants

8.2 Item descriptions

General descriptions of goods like "cable", "electronic components" must be avoided. Use distinct descriptions instead like "coaxial cable", "fiberoptic cable", "switches for voltage <60V"

8.3 Commodity codes

Commodity codes are used in customs declarations to group and classify items. The 6 digit classification governed by the World Trade Organisation is called the HS code or Harmonized System. Each country may make further distinctions by extension of the code. To learn more about the codes for your product and country, please refer to your chamber of commerce or customs office.
